Membership Update - Katherine Aitken-Young


We are at an all-time high for BVRI members with 360 in good standing (320 paid and 40 co-owners). We have 167 members who have renewed every year for the last five years (red line in table below. We have seen two spikes in membership in 2010 and 2012. In 2010 we did a major membership drive. In 2012 we did a similar membership drive and we added free pool membership as a "perk" for BVRI members. We have 24 more members in 2012 than we did in 2010.

The "new" members (green line) include both lapsed and brand new members.

In addition, the membership drive has added to our contact database. We have gotten 53 new email addresses with 2012 membership drive so we now have an active list of 571 email addresses.

Our email open rate is consistently about 56 - 58% or 260 - 270 people. Click through rates are anywhere from 11 - 60 percent depending on the content.

Lake Alpine Water Company Report—Kimi Johnson

Regarding the Bear Lake swimming ban: Working through some final issues. Hope to have the Governor sign everything by end of next week.

Regarding cloudy or colored water in some of the village water--this should be clearing up within the next few days. The reason for the colors/cloudiness is: Once the lake stops running off the top, the thermal strata in the lake develop and change. When they churn they pull a lot of iron and manganese from the soil at the bottom of the lake. LAWC filters as much out as they can using a precipitate. It takes a few days to adjust that amount and the precipitation doesn't happen fast enough so there are a couple of days when the levels are very high.

If anyone has any questions or comments about the water refund, please let Kimi know.
