Skyline Acquires Bear Valley Mountain Resort

Skyline International Development, Inc. has entered into a binding agreement of purchase and sale to acquire Bear Valley Mountain Resort. The agreement comes after several weeks of discussion with



the current ownership and local community leaders that had formed the Bear Valley Mountain Cooperative and who were also in the process of purchasing the resort. Closing is subject to the US Forest Service issuance of a permit to operate the resort, expected in 30 to 60 days.
