### **President's Report: Tom Fraser**

## Treasurer's Report & Membership Update: Jack Wedgwood/Katherine Aitken-Young

Financial reports were sent out by Treasurer, Jack Wedgwood, via email.

### **Architectural Review Committee Report: Kim LeMieux**

#### **Beach Operations and Improvement Report: Tom Fraser**

There are still 2 boats on the small beach and 5 on the large beach that need to be removed before the snow falls.

Discussion: require boat owners to get BVRI-issued stickers for boats to confirm they are BVRI members and so we can contact them at the end of the season to remove their boat before the snow falls. Beach Committee to follow up on this idea.

Discussion: Beach manager role is open for the upcoming summer. Committee will seek to fill this position next spring.

## Forest Management Report: Dave Morley/ Tom Fraser

About 150 letters went out to homeowners this year.

Forest Management committee has a database of all letters sent over the past 8 years. Discussion: Add data to report to close the loop and track if follow up is completed by homeowner; share data with Sheriff Denver Stoner and Rick Stephens to encourage follow up and enforcement.

Three property owners are scheduled to go to Court in November.
