### ***Join or Renew BVRI Membership for 2019***

Annual dues are \$125. Bear Valley property owners and non-property owners (in or outside of Bear Valley) are welcome to join. Whether you are renewing your membership or joining BVRI for the first time there are two steps to the process: completing the membership form and paying your dues. Both steps are required to become a member for 2019.

Step 1: Completing the Membership Form

Click on the Red link to the Membership form  
Make sure to "Submit" the form

## Step 2: Paying your dues

If paying by credit card, please have your card in hand before starting the membership form. By the way, you will receive an email reminding you about how to pay as well.
